1	The school is required to arrange its own website and upload Mandatory Public Disclosure as per appendix-IX of Circular No. 09/2021 dated 21.05.2021 on it and provide revised link of the same through SARAS Portal.
2	The school is required to obtain Water and Sanitation Certificate issued by Public Health and Sanitation Department as per format mentioned in Circular No : 12/2022 Dated 14 Oct 2022 (Appendix XIII) only.
3	It has been observed that the building of school is newly constructed and under completion of finishing work. Hence, the school is required to submit the compliance of Science Labs with equipment, Enriched Library, well developed play ground and other infrastructural facilities arranged in the school as per Affiliation Bye-Laws through SARAS Portal.
4	The school is required to appoint qualified PGTs and other staff as per norms and submit the compliance through SARAS Portal.

Failure to comply within the prescribed time shall invite financial penalty @ Rs. 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII , as the case may be.
